Dear Towson University Community:

Yesterday afternoon, through a social media post, the University learned of a hate/bias incident occurring on our campus. The posted report detailed two black students being followed by a group of white students who repeatedly called the two black students a racial slur.

Within hours, our Office of Inclusion and Towson University Police made contact with the student who first reported the incident via social media, and immediately launched an investigation into the incident through our Hate Crimes and Bias Incidents reporting process. We are still attempting to identify the students who were victimized and the suspects of this specific incident. We need the help of any campus community member who may know those involved or witnessed this event. Please contact Towson University Police at [410-704-4444](tel:410-704-4444) immediately.

Today I received these two emails from Towson University that infuriated me. I am a full supporter of the first amendment and praise people for voicing their opinions. However, the liberal bias and double standard at Towson and other universities across the country have taken things too far and lines have been crossed. I have always tended to be quiet and reserved, but I have had enough and am going to speak my mind.

These universities promote diversity among their student body, but seem to forget that not everyone is a liberal Trump hating Democrat. I had not heard of any planned walkout. I did walk across campus today for a 1:00 meeting in Hawkins Hall and noticed a crowd gathered in Freedom Square. I stopped briefly and assumed it was some type of student-organized rally. Nothing I heard indicated a protest of the election, and I, like most of the students I saw, moved on after a short time to be where we needed to be. In fact, when I left Hawkins Hall at 2:00 the crowd in the Square was gone.

It wasn't until I stopped by Bateman's to grab a quick bite to eat that I saw something reported by WJZ on FB calling it a 'student walkout.' I can tell you there's been no campus communication of a 'walkout' and as far as I could tell, the majority of students who have class here on a Mondays were in class today.
